OPTION 2: The professional entity name is a unique name or phrase, followed by the profession that will be practiced, and ending with the corporate indicator. For example, Care Connect Family Health Nurse Practitioner, P.C.

HOURLY RATE BILLING: If the initial name that is submitted for consent is rejected, all work done to revise and resubmit the proposed name will be billed at our hourly rate.
